**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
ESTRELLA DEL MAR RESORT FOR THE PURCHASE OF
VENUE WITH MEALS AND ACCOMMODATION
FOR THE CONDUCT OF CAPACITY BUILDING SEMINAR**

WHEREAS, the Department of Justice, National Prosecution Service Region 1 (DOJ-NPS R1) intends to procure meals, venue and accommodation for the conduct of Capacity Building Seminar on November 9-11, 2022 in Ilocos Sur;

WHEREAS, the subject procurement has an allocated budget amounting to Ninety Thousand Pesos (Php 90, 000.00) in the 2022 Annual Procurement Plan;

WHEREAS, the Bids and Awards Committee (BAC) of the DOJ-NPS R1, thru its Secretariat, initiated the procurement activity by: (1) posting the Request for Quotation (RFQ) in the PhilGEPS, DOJ Website and in a conspicuous place in the premises of the City of San Fernando, La Union continuously from September 1-8, 2022; and (2) sending the RFQ to three (3) suppliers, viz: (a) Estrella Del Mar Resort; (b) Santiago Cove Hotel and Restaurant; and (c) Ban-aw Resort;

WHEREAS, in response to the invitation, the same suppliers submitted their bids before the lapse of the deadline of submission of quotations;

WHEREAS, on September 10, 2022 at 10:00 a.m., the BAC conducted the opening of bids. Hereunder is the result of bid opening:

WHEREAS, based on the result, the BAC determined the financial proposal of Estrella Del Mar Resort in the amount of Eighty-Nine Thousand Eight Hundred Fifty Pesos (Php 89, 850.00) as the Lowest Calculated Bid;

WHEREAS, upon careful review and evaluation, the BAC found the offer of Estrella Del Mar Resort responsive to the requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby **RESOLVED** to recommend the award of contract for the subject procurement and the approval of the Purchase Order No. 2022-09-0023 in the amount of **Eighty-Nine Thousand Eight Hundred Fifty Pesos (Php 89, 850.00)** in favor of Estrella Del Mar Resort for being the Lowest Calculated and Responsive Bidder.
