RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF MATERIALS FOR THE REPAIR AND MAINTENANCE OF SERVICE VEHICLE FOR THE REGIONAL PROSECUTION OFFICE CARAGA VIA SMALL VALUE PROCUREMENT TO DY TeBAN HARDWARE & AUTO SUPPLY

WHEREAS, on October 05, 2022, the National Prosecution Service – Region XIII Bids & Awards Committee prepared a Purchase Request (PR No. 2022-10-007R) with a total approved budget of Two Thousand Five Hundred pesos (₱2,500.00) based on the approved FY 2022 APP (ref. page #17) – *Other General Services (Repair & Maintenance of official vehicles issued to NPS offices)* for the procurement of supplies & materials for the repair and maintenance of service vehicle (Innova SKW 547) of the Regional Prosecution Office Caraga;




