## RESOLUTION

### **A RESOLUTION RECOMMENDING THE APPROVAL OF PURCHASE ORDER NO. 18-2022 FOR THE PURCHASE OF CORK BOARD FOR BULLETIN (5w x 6l) FOR THE USE OF REGIONAL PROSECUTOR'S OFFICE, REGION VI.**

**WHEREAS**, there is a need to purchase of cork board for bulletin (5w x 6l) for the official use of Regional Prosecutor's Office, Region VI;

**WHEREAS**, the purchase of the aforementioned goods is included in the Supplemental Annual Procurement Plan No. 12 (SAPP No. 12) for the CY 2022 of the Department Proper;

**WHEREAS**, the above-mentioned project has an approved budget for contract of Ten Thousand Pesos (P 10,000.00);


**WHEREAS**, pursuant to Department Circular 011 dated 06 February 2012, with subject: Amended Policy on Review and Approval of Job Orders and Contracts in the Department of Justice, for purposes of expediting the process of all matters on procurement, each Purchase Order/Job Order/contract amounting to **EIGHT THOUSAND NINE HUNDRED NINETY EIGHT PESOS (P 8,998.00)** that is resorted through an alternative mode of procurement as indicated in the Department SAPP shall aside from establishing the legal, technical and financial capability of the concerned supplier/contractor, obtain approval from the DOJ BAC;

**WHEREAS**, considering that the amount involved in the subject procurement is **EIGHT THOUSAND NINE HUNDRED NINETY EIGHT PESOS (P 8,998.00)** an alternative mode of shopping is allowed by GPRA, provided, that the amount shall not exceed the threshold prescribed in Annex "H" of its Implementing Rules and Regulations.


