**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT  
TO PHILCOPY CORPORATION FOR THE PURCHASE OF  
CONSUMABLES FOR PHOTOCOPIER MACHINES (KYOCERA  
MODEL: Taskalfa 3010i &Taskalfa 2200)**

**WHEREAS**, there is an urgent need to purchase consumables for Photocopier Machines (KYOCERA Model: Taskalfa 3010i &Taskalfa 2200) for the Regional Prosecution Office, Provincial Prosecution and City Prosecution Offices, Region IV;

**WHEREAS**, the purchase of the aforementioned items is included in the Annual Procurement Plan (APP) for CY 2022 of the National Prosecution Service, Region IV with Approved Budget for the Contract (ABC) amounting to **ONE MILLION THREE HUNDRED FIFTEEN THOUSAND SIX HUNDRED TWENTY PESOS ONLY P1,315,620.00**;

**WHEREAS**, Section 50.(c) of the Revised Implementing Rules and Regulations of R.A. 9184 provides that: "*Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.*";

**WHEREAS**, Philcopy Corporation is the sole exclusive distributor in the Philippines of the consumables of photocopier machines (KYOCERA Model: Taskalfa 3010i &Taskalfa 2200) with Certificate of Exclusivity signed by TAKUMA KIMURA;

**WHEREAS**, upon evaluation of the Bid and Award Committee (BAC) and its Technical Working Group, Philcopy Corporation submitted a quotation amounting to **₱1,315,620.00** for consumables for photocopier machines (KYOCERA Model: Taskalfa 3010i &Taskalfa 2200) for the Region Prosecution Office, Provincial Prosecution and City Prosecution Offices of Region IV, and found to be technically, legally and financially compliant with the requirement under 2016 Revised IRR of the RA No. 9184, and considered to be the Lowest Calculated and Responsive Quotation (LCRQ);

**NOW, THEREFORE,** We the Bids and Awards Committee hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract to PHILCOPY CORPORATION for purchased of consumables for Photocopier Machines (KYOCERA Model: Taskalfa 3010i & Taskalfa 2200) through Direct Contracting in the amount of **ONE MILLION THREE HUNDRED FIFTEEN THOUSAND SIX HUNDRED TWENTY PESOS ONLY (P 1,315,620.00).**
