RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT AND PURCHASE OF VARIOUS RUBBER STAMPS THROUGH SMALL VALUE PROCUREMENT PURSUANT TO THE IMPLEMENTING REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, Regional Prosecution Office VI through its Bids and Awards Committee (BAC), posted the Request for Quotation (RFQ) for the above mentioned project through posting at the Philippine Government Electronic Procurement System (PHILGEPS), the Iloilo Hall of Justice and the Iloilo Provincial Capitol;

WHEREAS, the posting was made last September 6, 2022 to September 9, 2022;

WHEREAS, during the opening of bids conducted by the Regional Prosecution Office Bids and Awards Committee, the following submitted their bids and quotation: 1. Iloilo Izeem Commercial, 2. Iloilo Yca Dale Trading and 3. Otani Bazar;

WHEREAS, the submission and opening of bids were scheduled on September 9, 2022 at 2:00P.M.;


