**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO C & G REFRIGERATION AND AIRCONDITIONING SERVICE CENTER FOR THE PROCUREMENT OF AIR-CON CLEANING SERVICES THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (SEC. 53.9)**

**WHEREAS**, there is a need for the PRO-Caraga to procure air-con cleaning services for its air-conditioner units;

**WHEREAS**, the BAC Secretariat prepared a purchase request (PR # 2023-08-0006R) with an approved budget of Four Thousand Five Hundred Sixty pesos (₱4,560.00);
