“RESOLUTION RECOMMENDING FOR THE APPROVAL OF AWARD OF THE WINNING BID FOR THE PROCUREMENT OF TELEPHONE & INTERNET SUBSCRIPTION, FIBER OPTIC INTERNET CONNECTION, MINIMUM OF 100mbps OF INTERNET BANDWIDTH FOR DOJ-NPS REGION-VIII FIELD OFFICES”

WHEREAS, there is an approved Purchase Request (PR) dated May 9, 2023, with the Requisition and Issue Slip (RIS), for the procurement of telephone & internet subscription, Fiber Optic Internet connection, minimum of 100mbps of internet bandwidth for the Regional Prosecution Office VIII field offices such as: 1.) OPP Biliran; 2.) OPP Northern Samar; 3.) OPP Samar; OPP Leyte with sub-offices 4.) Ormoc, 5.) Baybay, and 6.) Hilongos; 7.) OPP Southern Leyte; 8.) OCP Baybay; 9.) OCP Borongan; and 10.) OCP Calbayog;

WHEREAS, said procurement is included in the Supplemental Annual Procurement Plan (SAPP) Number 3 approving the funding of eight (8) months subscription and one-time installation fee for the procurement of telephone and internet connection of the ten (10) offices with an Approved Budget for the Contract (ABC) of TWO HUNDRED FORTY-ONE THOUSAND NINE-HUNDRED TWENTY (P241,920.00) pesos only;

WHEREAS, the BAC passed BAC Resolution No. 010 dated May 10, 2023, approving the purchase through Negotiated - Small Value Procurement;

WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:

1. Posted the request for the Price Quotation on May 11, 2023, at the Philippine Government Electronic Procurement System (Philgeps), Bulwagan ng Katarungan Bulletin Board, Tacloban City, official DOJ website page and official RPO-VIII Procurement Facebook page and set submission for the Price Quotation on or before May 15, 2023;
2. Received quotations from the three (3) suppliers, to wit:

2.2 PLDT, INC., 117 P. Zamora St., Brgy. 15, Tacloban City, no Philgeps Registration submitted, Mayor's Business Permit No. 2023 07114;

2.3 FIL PRODUCTS, P. Burgos St, Tacloban City, no documents submitted;

3. Received the three (3) price quotations from the aforementioned suppliers on May 15, 2023;

WHEREAS, on May 15, 2023, at 1:00 o'clock in the afternoon, BAC conducted a pre-examination of bids to determine bidders' compliance with the technical component requirements based on submitted documents;

WHEREAS, among the three (3) bidders, only INNOVE COMMUNICATIONS INC., was determined eligible and compliant with Section 23 Rule VIII of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

WHEREAS, submitted quotations has been consolidated in the Abstract of Canvass;

NOW, THEREFORE, on the basis of the foregoing, it is HEREBY RECOMMENDED to the Head Of Procuring Entity (HOPE) that the telephone & internet subscription, Fiber Optic Internet connection, minimum of 100mbps of internet bandwidth for the Regional Prosecution Office VIII field offices be procured from "INNOVE COMMUNICATIONS, INC.", being the eligible bidder and available in ALL areas where the prosecution offices are located.
