RESOLUTION NO. 2023- RATTFXI-BTPROS-B1,2

RECOMMENDING THE AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH MEALS and ACCOMMODATION FOR THE BASIC TRAINING ON TIP AND OSAEC FOR DOJ-NPS XI PROSECUTORS (BATCH 1 & 2) ON OCTOBER 10-11, 2023 AND OCTOBER 12-13, 2023 THROUGH SECTION 53.10 (NEGOTIATED PROCUREMENT-LEASE OF REAL PROPERTY AND VENUE) OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, included in the FY 2023 Supplemental Annual Procurement Plan No. 7 is the Lease of Venue with Meals and Accommodation for the **Basic Training on TIP and OSAEC for DOJ-NPS XI Prosecutors (Batch 1 & 2)** on 10 to 11 October 2023 and 12 to 13 October 2023, respectively, with an Approved Budget for the Contract (ABC) of **Four Hundred Twenty-three Thousand Pesos (P 423,000.00)**, to be undertaken through Section 53.10 (under Negotiated Procurement-Lease of Real Property and Venue) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, in compliance with the 2016 RIRR of RA No. 9184, Consolidated Guidelines for the Alternative Methods of Procurement, item V-D 9 (b) (i), a survey was conducted among government agencies to determine if there is an available publicly-owned venue that complies with the requirements of the Procuring Entity, however, none was found;

WHEREAS, on September 11 to 14, 2023, the Regional Prosecution Office XI (RPO XI) Bids and Awards Committee (BAC), thru its Secretariat, initiated the procurement activity by sending Request for Quotation (RFQ) No. **RATTFXI-01-BTPROS 2023 and RPOXI-RATTFXI-02-2BTPROS2023** to at least three (3) suppliers within Davao City;

WHEREAS, prior to the deadline, the BAC Secretariat obtained three (3) price quotations from the following suppliers:

WHEREAS, the table of rating prepared by the BAC Secretariat indicated that the proposal of Park Inn by Radisson Davao is the most advantageous to the government in terms of price, amenities, space, location and site condition;

WHEREAS, after careful review and evaluation of the documentary, technical and financial requirements submitted by the bidder, the BAC declares Park Inn by Radisson Davao as the lowest calculated and responsive quotation;

WHEREAS, Section 37 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity (HOPE) or his/her duly authorized representative;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the RPO XI BAC, **HEREBY RESOLVED** to recommend for the approval of the HOPE the award of the following contracts of Lease of Venue with Meals and Accommodations:

1. For the **Basic Training on TIP and OSAEC for DOJ-NPS XI Prosecutors Batch 1** on 10 to 11 October 2023 to Park Inn by Radisson Davao, the lowest calculated and responsive quotation, in the amount of **Two Hundred Ten Thousand Six Hundred Fifty Pesos (P 210,650.00)**; and
2. For the **Basic Training on TIP and OSAEC for DOJ-NPS XI Prosecutors Batch 2** on 12 to 13 October 2023, to Park Inn by Radisson Davao, the lowest calculated and responsive quotation, in the amount of **Two Hundred Ten Thousand Six Hundred Fifty Pesos (P 210,650.00)**.
