RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO GORILLA TRADING FOR THE PRINTING OF THE DEPARTMENT OF JUSTICE 2022 ANNUAL REPORT

WHEREAS, there is a need to print the 2022 Department of Justice (DOJ) Annual Report;

WHEREAS, the printing of the DOJ 2022 Annual Report is included in the CY 2023 Annual Procurement Plan (APP) under negotiated procurement with an allotted budget of Six Hundred Fifty Thousand Pesos (₱ 650,000.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project with an approved budget for the contract of Five Hundred Sixty-Nine Thousand Five Hundred Pesos (₱ 569,500.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for nine (9) calendar days starting 26 April 2023;

No. 9184 and its Implementing Rules and Regulations
