RECOMMENDING AWARD OF CONTRACT FOR THE TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP (MEALS, VENUE AND ACCOMMODATION) ON 16-18 AUGUST 2023 UNDER NEGOTIATED PROCUREMENT (LEASE OF VENUE 53.10) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Three Hundred Seventy-Five Thousand Pesos Only (P375,000.00) for the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP (Meals, Venue and Accommodation) on 16-18 August 2023;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the RPO BAC Secretariat initiated the procurement activity by sending Request for Quotation (RFQ) for the procurement of the above-mentioned project to the following supplier;

1. Patio De San Jose Resort and Convention Center;
2. La Venezia Hotel and Spa, Inc.;
3. Conrado Cecilia Holdings Inc.

WHEREAS, the submission and opening of bids was scheduled on 24 July 2023;

WHEREAS, request for quotations from suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;


WHEREAS, per evaluation, bid of Patio De San Jose Resort and Convention Center is found to be the Lowest Calculated Responsive Bid (LCRB);

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the RPO V - BAC, hereby RECOMMEND to the Regional Prosecutor, the following:

1. **AWARD OF CONTRACT** via Lease of Venue to Patio De San Jose Resort and Convention Center for the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP (Meals, Venue and Accommodation) on 16-18 August 2023, in the amount of Three Hundred Seventeen Thousand Five Hundred Pesos Only (Php317,500.00), inclusive of appropriate taxes and fees.


