RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PERRY A TRADING CORP. FOR THE SUPPLY AND DELIVERY OF FIVE (5) UNITS AIR-COOLER FOR THE USE OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING

WHEREAS, a Request for Quotation (RFQ) for the procurement of five (5) units of Air-Cooler for the use of the Inter-Agency Council Against Trafficking (IACAT) with an approved budget for the contract of Thirty-Four Thousand Nine Pesos (₱ 34,009.00) was posted in the Department of Justice (DOJ) and PhilGEPS websites, and in a conspicuous place in the Department on 29 September 2023;

WHEREAS, the procurement of the said project is included in the approved CY-2023 Supplemental Annual Procurement Plan (SAPP) No. 7 under negotiated procurement with an allotted budget of Thirty-Four Thousand Nine Pesos (₱ 34,009.00);

WHEREAS, in response to the posting of the said RFQ, six (6) prospective suppliers submitted their quotations, *to wit*:

WHEREAS, the DOJ Bids and Awards Committee (BAC) through Resolution No. SVP2023-09-226 dated 18 October 2023 recommended to the Head of Procuring Entity (HOPE) the award of contract to Ace Hardware Philippines, Inc. after having been found by the BAC-Technical Working Group (TWG) to be legally, financially, and technically capable to undertake the subject procurement, having submitted the Lowest, Calculated, and Responsive Quotation;


WHEREAS, the BAC thereafter issued Resolution No. SVP2023-09-226A cancelling Resolution No. SVP2023-09-226 dated 18 October 2023 pursuant to the letter dated 27 October 2023 from Mr. Jaime L. Gilbuela II, Senior Manager-Customer Service, Ace Hardware Philippines, Inc., informing the Department that they are withdrawing their participation in the project due to payment issues and considering that the DOJ does not have a credit account with the said supplier, they cannot transact and generate delivery and sales documents without payment;

WHEREAS, pursuant to the provisions of R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations, the BAC-TWG proceeded to review and evaluate the second lowest calculated bidder, PERRY-A-TRADING CORPORATION, and found the same to be legally, financially, and technically capable to undertake the subject procurement;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to Negotiated Procurement thru Small Value Procurement, and further recommend the award of contract to **PERRY-A-TRADING CORPORATION** for the supply and delivery of five (5) units Air-Cooler for the use of the IACAT of the Department of Justice in the amount of **TWENTY-NINE THOUSAND SIX HUNDRED PESOS (₱ 29,600.00)** following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


