SUBJECT: RESOLUTION RECOMMENDING THE AWARD OF CONTRACT OF LEASE OF VENUE WITH MEALS AND ACCOMODATION FOR THE CONDUCT OF THE “TRAINING OF PNP/LAW ENFORCERS ON CASE BUILD-UP BY THE DOJ PROSECUTORS” ON OCTOBER 23-27, 2023

WHEREAS, for the implementation of DOJ Department Circular No. 20, the Department of Justice; Regions 3, will hold its “TRAINING OF PNP/LAW ENFORCERS ON CASE BUILD-UP BY THE DOJ PROSECUTORS” on October 23-27, 2023;

WHEREAS, the procurement of lease of venue which includes an allocation for meals and accommodation for the said event has an allotted budget of **Seven Hundred Fifty Thousand Pesos (Php 750,000.00)** for **One Hundred (100) pax** under Negotiated Procurement (Sec. 53.10 of R.A. 9184) as mode of procurement;

WHEREAS, in a Cost Benefit Analysis prepared by Mr. Romar A. Arciga, Administrative Officer V, Office of the Regional Prosecutor, Region III, it was stated that after checking meeting venues in and around Nueva Ecija, it appears that there is no government facility available which offered lease of venue that satisfied the requirements of the said event;

WHEREAS, the Department of Justice, Bids and Awards Committee – National Prosecution Service Region III (BAC-NPS Region III), initiated the procurement activity by sending the Request for Quotation to Three (3) lessors, viz: (1) Microtel by Wyndham Cabanatuan; (2) Hotel Consuelo; and (3) Acropolis North Water Camp and Country Club; and in response to the procurement opportunity, the above three lessors submitted their quotation/proposal and the necessary documents in their respective RFQs;

WHEREAS, based on the quotations submitted by the above listed lessors, it appears that Microtel by Wyndham Cabanatuan does not accept send bill payment arrangement, hence, said lessor was disqualified;

WHEREAS, below are the rating factors for lease of venue submitted by the end-user pursuant to the methodology prescribed by Appendix B, Annex “H” of the 2016 Implementing Rules and Regulations of R.A. No. 9184;

WHEREAS, upon due deliberation for the procurement of lease of venue with allocation for meals and accommodation, the BAC-NPS Region III found the offer/price of **HOTEL**, as the responsive bid to the requirements based on the above-stated rating factors and is legally, financially and technically capable to undertake the said project and thus be awarded the Contract/Purchase Order for the subject procurement;


NOW THEREFORE, for and in consideration of the foregoing premises, the members of the BAC-NPS Region III, resolves, as it is hereby resolved, to recommend the confirmation of resort to Negotiated Procurement – Lease of Venue, and further recommend the award of contract to **HOTEL CONSUELO**, Sta. Rosa, Nueva Ecija, as the venue of the Live-in Training of PNP/Law Enforcers on Case Build-Up by the DOJ Prosecutors (Sessions 11 & 12) on October 23-27, 2023 in the amount of **Six Hundred Ninety Nine Thousand Pesos (Php 699,000.00)**, following the procedures prescribed in R.A. 9184 and its 2016 Revised Implementing Rules and Regulations.


