**RESOLUTION No. 2023-07-025**

**RECOMMENDING THE AWARD OF CONTRACT TO OHANA'S CONSUMER  
GOODS TRADING FOR THE SUPPLY AND DELIVERY OF VARIOUS  
CONSUMABLES FOR PRINTERS  
FOR NPS- REGION 1**

**WHEREAS**, included in the CY 2023 Supplemental Annual Procurement Plan No. 6 of the National Prosecution Service, Region 1 is the procurement of various consumables for printers with an allocated budget of Two Thousand Two Hundred Sixty-Four Pesos and 41/100 (P2,264.41) to be procured in accordance with Sec. 53.9 (Negotiated Procurement-Small Value Procurement) of the 2016 Revised IRR of RA 9184;

**WHEREAS**, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC), posted the subject procurement in a conspicuous place in the premises of the Justice Hall, Sevilla, San Fernando City, La Union continuously from July 18, 2023 to July 20, 2023;

**WHEREAS**, on July 18, 2023, the BAC, thru its secretariat, also sent the Request for Quotation (RFQ) for the above project to five (5) prospective suppliers, namely: (1) Paper Cart Marketing, Inc; (2) L.U. Morning Star Enterprises (3) ELYU Supply Enterprises OPC; (4) Ohana's Consumer Goods Trading; and (5) Pandayan Bookshop Inc.

**WHEREAS**, before the lapse of the deadline for submission of quotations at 10:00 a.m. on July 21, 2023, five (5) suppliers have submitted their proposals. Hereunder are their respective bids:

**WHEREAS**, based on the result, the bid of Pandayan Bookshop Inc. was declared as the Lowest Calculated Bid, however, the BAC declared the supplier disqualified for award for being non-responsive;

**WHEREAS**, the BAC proceeded with the evaluation of the quotation and other documents submitted by the 2<sup>nd</sup> Lowest Calculated Bidder, Ohana's Consumer Goods Trading;

**WHEREAS**, upon careful review, verification and validation, Ohana's Consumer Goods Trading was established to have complied with all the required legal, technical and financial requirements. Thus, it was recommended to declare the said bidder as responsive and eligible bidder and be considered for award for offering the Lowest Calculated and Responsive Bid of Two Thousand Two Hundred Sixty Pesos (P2,260.00);

**NOW, THEREFORE**, we the Members of the Bids and Awards Committee, hereby RESOLVE to recommend to the Head of the Procuring Entity the award of contract for the subject procurement to Ohana's Consumer Goods Trading and the approval of Purchase Order No. 2023-07-023 in the amount of Two Thousand Two Hundred Sixty Pesos (P2,260.00).
