RESOLUTION NO. 2023-RPOXI-DC20-R/O-01

RECOMMENDING THE AWARD OF CONTRACT FOR THE LEASE OF VENUE WITH MEALS and ACCOMMODATION FOR THE TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP (1st Roll-out) ON 30 AUGUST to 01 SEPTEMBER 2023 THROUGH SECTION 53.10 (NEGOTIATED PROCUREMENT-LEASE OF REAL PROPERTY AND VENUE) OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, included in the FY 2023 Supplemental Annual Procurement Plan No. 5 is the Lease of Venue with Meals and Accommodation for the **Training of DOJ Prosecutors And Law Enforcement Agents of the PNP** (1st Roll-out) on 30 August TO 01 September 2023, with an Approved Budget for the Contract (ABC) of **Three Hundred Sixty-five Thousand Pesos (P 365,000.00)**, to be undertaken through Section 53.10 (under Negotiated Procurement-Lease of Real Property and Venue) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, in compliance with the 2016 RIRR of RA No. 9184, Consolidated Guidelines for the Alternative Methods of Procurement, item V-D 9 (b) (i), a survey was conducted among government agencies to determine if there is an available publicly-owned venue that complies with the requirements of the Procuring Entity, however, none was found;

WHEREAS, on July 24 to 27, 2023, the Regional Prosecution Office XI (RPO XI) BAC, thru its Secretariat, initiated the procurement activity by sending Request for Quotation (RFQ) No. 2023-RPOXI-DC20-R/O-01 to at least three (3) suppliers within Davao City;

WHEREAS, prior to the deadline, the BAC Secretariat obtained two (2) price quotations from the following suppliers:

WHEREAS, the table of rating prepared by the BAC Secretariat indicated that the proposal of Dynasty Management & Development Corporation (Grand Regal Hotel Davao) is the most advantageous to the government in terms of price, amenities, space, location and site condition;

WHEREAS, after careful review and evaluation of the documentary, technical and financial requirements submitted by the bidder, the BAC declares Dynasty Management & Development Corporation (Grand Regal Hotel Davao) as the lowest calculated and responsive quotation;

WHEREAS, Section 37 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity (HOPE) or his/her duly authorized representative;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the RPO XI BAC, **HEREBY RESOLVED** to recommend for the approval of the HOPE that the contract of Lease of Venue with Meals and Accommodations for the **Training of DOJ Prosecutors and Law Enforcement Agents of the PNP** (1st Roll-out) on 30 August TO 01 September 2023 be awarded to Dynasty Management & Development Corporation (Grand Regal Hotel Davao), the single calculated and responsive quotation, in the amount of **Three Hundred Twenty-three Thousand Eight Hundred Pesos (P 323,800.00)**.


