RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS CONSUMABLES FOR PRINTERS FOR NPS REGION V – UNDER SHOPPING OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF THE REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of Two Hundred Twenty-Three Thousand Nine Hundred Twenty Pesos (P223,920.00) for the Supply and Delivery of Various Consumables for Printers for NPS Region V;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, on 09 August 2023, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

1. Albay Computer & Electronics Supplies & Repair;
2. Omax Enterprises;
3. Denver's Computer Shoppe, Inc.

WHEREAS, the submission and opening of bids was scheduled on 15 August 2023;

WHEREAS, request for quotations from suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

7. J4Inks Office and School	Php154,368.00	Ineligible, non-compliant with the documentary requirements, specifically, the attached Omnibus Sworn Statement is not notarized.
8. Amada Enterprises	Php51,840.00	Ineligible, non-compliant with the documentary requirements, all attachments are photocopy.
9. Ladansico Non-Specialized Wholesale Trading	Php201,600.00	Ineligible, due to incomplete entry in the RFQ, specifically no validity offer.




