RESOLUTION No. 2023-07-026

BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR LEASE OF VENUE WITH MEALS AND ACCOMMODATION FOR THE CONDUCT OF TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP - SESSIONS 1&2

WHEREAS, included in the approved CY 2023 Supplemental Annual Procurement Plan No. 5 of the Department of Justice (DOJ) is the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP consisting of several sessions to be conducted by the Regional Prosecution Offices of DOJ.

WHEREAS, there are twenty-two (22) sessions allotted for NPS- Region 1;

WHEREAS, NPS- R1 intends to hold the 1st and 2nd sessions of the said training in San Juan, La Union on July 31 to August 4, 2023 with an approved budget for the contract of Seven Hundred Fifty Thousand Pesos (Php 750, 000.00) and shall be undertaken through Section 53.10 (Lease of Venue) of the 2016 Revised IRR of RA 9184;

WHEREAS, the BAC issued Resolution No. 2023-07-024, duly approved by the Head of the Procuring Entity (HOPE), stating that there is no available government-owned facilities within the area that complies with the requirements of the end-user, hence, the need to resort to privately-owned facilities;

WHEREAS, on July 24, 2023, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC) Secretariat, initiated the procurement activity by sending the Request for Quotation to five (5) lessors, viz: (1) Kahuna Hotel; (2) Puerto de San Juan; (3) Plaza De Castiel Hotel; (4) Ciabel Hotel and Fitness Center; and (5); EM Royale Hotel;

WHEREAS, in response to the invitation, the BAC only received two (2) quotations from the following suppliers:

EM Royale Hotel	722, 400.00

WHEREAS, Plaza De Castiel Hotel and Spa, being the lessor who offered the lowest calculated bid, underwent post-qualification and evaluation rating in

accordance with the technical specifications prepared by the BAC pursuant to Appendix B, Annex H of the 2016 Revised IRR if RA 9184;

WHEREAS, after review and evaluation, the BAC found Plaza De Castiel Hotel and Spa non-responsive as it only garnered a rating of 86.65%, lower than the 90% passing rate set by the BAC;

WHEREAS, the BAC proceeded with the evaluation of the proposal and other documents sent by EM Royale Hotel and repeated the post-qualification and evaluation process to the said bidder;

WHEREAS, upon careful review and evaluation, EM Royale Hotel garnered a passing rate of 99.05%. Thus, the BAC found the offer of EM Royale Hotel responsive to the requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;

NOW, THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE to recommend to the Head of the Procuring Entity the award of contract for lease of venue with meals and accommodation for the subject procurement in favor of EM Royale Hotel and the approval of Purchase Order No. 2023-07-024 with a contract price of **Seven Hundred Twenty-Two Thousand Four Hundred Pesos (P722,400.00)**.


