RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS COMMON OFFICE SUPPLIES NOT AVAILABLE IN THE PROCUREMENT SERVICE FOR NPS REGION V –REPOSTING UNDER SHOPPING OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF THE REPUBLIC ACT (RA) NO. 9184

WHEREAS, the Department approved the budget of One Hundred Seventy-Nine Thousand Eight Hundred Seventy-Seven Pesos and Fifty-Six Centavos (P179,877.56) for the Supply and Delivery of Various Common Office Supplies not available in the Procurement Service, for NPS Region V;

WHEREAS, the BAC declared first failure of bidding due to no eligible bidder and recommended the conduct of Re-bidding with Re-posting under BAC Resolution No. 2023-07-021 dated 21 July 2023;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, BAC Secretariat posted the Request for Quotations (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, on 09 August 2023, the RPO V- Bids and Awards Committee Secretariat sent Request for Quotations (RFQs) for the procurement of the above mentioned project to the following suppliers, viz;

1. New Silahis Office Supplies Trading;
2. Legazpi Jebson Trading;
3. Lucky Educational Supply.

WHEREAS, the submission and opening of bids was scheduled on 15 August 2023;

WHEREAS, request for quotations from suppliers were obtained by the BAC Secretariat on different dates, attested by accomplished RFQs;

5. Ladansico Non-Specialized Wholesale Trading		Php144,137.00	Ineligible due to incomplete quotation, some items have no price quotation.


WHEREAS, per evaluation, bid of New Silahis Office Supplies Trading is found to be the Lowest Calculated Responsive Bid;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW THEREFORE, for and in consideration of the foregoing, We, the members of the RPO V-BAC, hereby **RECOMMEND** to the Regional Prosecutor, the following:

- 1. AWARD OF CONTRACT** via Shopping to New Silahis Office Supplies Trading for the Supply and Delivery of Various Common Office Supplies not Available in the Procurement Service for NPS Region V Re-posting, in the amount of One Hundred Fifty-Eight Thousand Eight Hundred Thirty-One Pesos and Ten Centavos (Php158,831.10) inclusive of appropriate taxes and fees;


