RESOLUTION RECOMMENDING AWARD OF CONTRACT FOR THE MEALS, VENUE, AND ACCOMMODATION FOR THE TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP ON 23-25 OCTOBER 2023 & 25-27 OCTOBER 2023 UNDER NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE, SECTION 53.10) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Seven Hundred Fifty Thousand Pesos Only (₱ 750,000.00) for the Meals, Venue, and Accommodation for the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP on 23-25 October 2023 & 25-27 October 2023;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, DOJ NPS Region V thru its BAC Secretariat advertised the Request for Quotation (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ Website, and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the BAC Secretariat sent Request for Quotations (RFQ) for the procurement of the above-mentioned project to the following suppliers on 23 August 2023, to wit: (1) Conrado Cecilia Holdings, Inc.; (2) Patio de San Jose Resort & Convention Center, Inc.; and (3) The Oriental Hospitality and Restaurant Management Services Inc.; and (4) Eljoe's Catering Services;

WHEREAS, the Submission and Opening of Bids was scheduled on 30 August 2023;

WHEREAS, four (4) quotations from different suppliers were received by the BAC Secretariat on different dates, attested by the accomplished Request for Price Quotations (RFQ), and the following is the result of the evaluation during the Opening of Bids:

3. The Oriental Hospitality and Restaurant Management Services Inc.		₱ 755,000.00	- INELIGIBLE , due to no attached requirements, and the bid offer is above the Approved Budget for the Contract (ABC).
4. Eljoe's Catering Services		₱ 600,000.00	- INELIGIBLE , due to incomplete requirements, specifically, no attached BIR Cert. of Registration, SEC/DTI Registration, and Income/Business Tax Return.


WHEREAS, after judicious evaluation of the submitted quotations, bid of Conrado Cecilia Holdings, Inc. is found to be within the Approved Budget for the Contract (ABC), and compliant with the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the RPO V - BAC, hereby RECOMMEND to the Regional Prosecutor, the following:

- 1. AWARD OF CONTRACT** via Lease of Real Property and Venue to Conrado Cecilia Holdings, Inc. for the Meals, Venue, and Accommodation for the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP on 23-25 October 2023 & 25-27 October 2023, in the amount of Six Hundred Ninety Thousand Pesos Only (₱ 690,000.00), inclusive of appropriate taxes and fees.




