**RESOLUTION RECOMMENDING AWARD OF CONTRACT FOR THE
PROCUREMENT OF MATERIALS FOR THE RE-PAINTING OF GANG CHAIR,
RECEIVING AREA, AND STOCKROOM OF THE REGIONAL PROSECUTION
OFFICE V UNDER NEGOTIATED PROCUREMENT (SMALL VALUE
PROCUREMENT), SECTION 53.9 OF THE REVISED IMPLEMENTING RULES
AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.**

WHEREAS, the Department approved the budget of Ten Thousand Eight Hundred Eighty-One Pesos & 20/100 Only (₱ 10,881.20) for the Procurement of Materials for the Re-painting of Gang Chair, Receiving Area, and Stockroom of the Regional Prosecution Office V;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, DOJ NPS Region V thru its BAC Secretariat advertised the Request for Quotation (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ Website, and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the BAC Secretariat sent Request for Quotations (RFQ) for the procurement of the above-mentioned project to the following suppliers on 14 July 2023, to wit: (1) Legazpi Grace Home Builders Supply, Inc.; (2) Citi Hardware; and (3) Unico Trading;

WHEREAS, the Submission and Opening of Bids was scheduled on 20 July 2023;

WHEREAS, three (3) quotations from different suppliers were received by the BAC Secretariat on different dates, attested by the accomplished Request for Price Quotations (RFQ), and the following is the result of the evaluation during the Opening of Bids:

BIDDER	ABC	BID OFFER	REMARKS
1. Legazpi Grace Home Builders Supply, Inc.	₱ 10,881.20	₱ 10,062.00	- ELIGIBLE, compliant with the specifications and requirements, and the bid offer is within the Approved Budget for the Contract (ABC).
2. Citi Hardware		₱ 7,605.00	- INELIGIBLE, due to no submitted documentary requirements, and no bid offer on one item.
3. Unico Trading		₱ 8,972.00	- INELIGIBLE, due to incomplete entries in the RFQ form, and incomplete documentary requirements.


WHEREAS, after judicious evaluation of the submitted quotations, bid of Legazpi Grace Home Builders Supply, Inc. is found to be within the Approved Budget for the Contract (ABC), and compliant with the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


