SUBJECT: RESOLUTION RECOMMENDING THE AWARD OF CONTRACT OF LEASE OF VENUE WITH MEALS AND ACCOMODATION FOR THE CONDUCT OF THE “TRAINING OF PNP/LAW ENFORCERS ON CASE BUILD-UP BY THE DOJ PROSECUTORS” ON SEPTEMBER 18-22, 2023

WHEREAS, for the implementation of DOJ Department Circular No. 20, the Department of Justice; Regions 3, will hold its “TRAINING OF PNP/LAW ENFORCERS ON CASE BUILD-UP BY THE DOJ PROSECUTORS” on September 18-22, 2023;

WHEREAS, the procurement of lease of venue which includes an allocation for meals and accommodation for the said event has an allotted budget of **Seven Hundred Fifty Thousand Pesos (Php 750,000.00)** for **One Hundred (100) pax** under Negotiated Procurement (Sec. 53.10 of R.A. 9184) as mode of procurement;

WHEREAS, in a Cost Benefit Analysis prepared by Mr. Romar A. Arciga, Administrative Officer V, Office of the Regional Prosecutor, Region III, it was stated that after checking meeting venues in and around Subic, Zambales, it appears that there is no government facility available which offered lease of venue that satisfied the requirements of the said event;

WHEREAS, the Department of Justice, Bids and Awards Committee – National Prosecution Service Region III (BAC-NPS Region III), initiated the procurement activity by sending the Request for Quotation to Four (4) lessors, viz: (1) Searabeol Hotel Grand Leisure Hotel; (2) Terrace Hotel (Hanakyung Corp.); (3) Subic Bay Peninsular Hotel; and (4) Freeport Mansion Leisure Corp; and in response to the procurement opportunity, the above four lessors submitted their quotation and the necessary documents in their respective RFQs;

WHEREAS, below are the rating factors for lease of venue submitted by the end-user pursuant to the methodology prescribed by Appendix B, Annex “H” of the 2016 Implementing Rules and Regulations of R.A. No. 9184;

WHEREAS, upon due deliberation for the procurement of lease of venue with allocation for meals and accommodation, the BAC-NPS Region III found the offer/price of **SUBIC BAY PENINSULAR HOTEL**, as the responsive bid to the requirements based on the above-stated rating factors and is legally, financially and technically capable to undertake the said project and thus be awarded the Contract/Purchase Order for the subject procurement;

NOW THEREFORE, for and in consideration of the foregoing premises, the members of the BAC-NPS Region III, resolves, as it is hereby resolved, to recommend the confirmation of resort to Negotiated Procurement – Lease of Venue, and further recommend the award of contract to **SUBIC BAY PENINSULAR HOTEL**, as the venue of the Live-in Training of PNP/Law Enforcers on Case Build-Up by the DOJ Prosecutors (Sessions 3 & 4) on September 18-22, 2023 in the amount of **Six Hundred Thousand Pesos (Php 600,000.00)**, following the procedures prescribed in R.A. 9184 and its 2016 Revised Implementing Rules and Regulations.


