RESOLUTION RECOMMENDING AWARD OF CONTRACT FOR THE TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP (MEALS, VENUE, AND ACCOMMODATION) ON 09-11 AUGUST 2023 UNDER NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE, SECTION 53.10) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Three Hundred Seventy-Five Thousand Pesos Only (₱ 375,000.00) for the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP (Meals, Venue, and Accommodation) on 09-11 August 2023;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, DOJ NPS Region V thru its BAC Secretariat advertised the Request for Quotation (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPs), DOJ Website, and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the BAC Secretariat sent Request for Quotations (RFQ) for the procurement of the above-mentioned project to the following suppliers on 18 July 2023, to wit: (1) Pepperland Hotel & Leisures Corporation; (2) Ninong's Hotel; and (3) Hotel St. Ellis;

WHEREAS, the Submission and Opening of Bids was scheduled on 24 July 2023;

WHEREAS, three (3) quotations from different suppliers were received by the BAC Secretariat on different dates, attested by the accomplished Request for Price Quotations (RFQ), and the following is the result of the evaluation during the Opening of Bids:

1. Pepperland Hotel & Leisures Corporation	₱ 375,000.00	₱ 375,000.00	- INELIGIBLE, due to: (1) incomplete requirement, specifically, no Income Tax Return; (2) expired PhilGEPs Certificate; (3) and incomplete entry in the RFQ form.
2. Ninong's Hotel		₱ 365,000.00	- INELIGIBLE, due to some of the Income Tax Return pages are not properly authenticated.
3. Hotel St. Ellis		₱ 317,500.00	- ELIGIBLE , compliant with the specifications and requirements, and the bid offer is within the Approved Budget for the Contract (ABC).

WHEREAS, after judicious evaluation of the submitted quotations, bid of Hotel St. Ellis is found to be within the Approved Budget for the Contract (ABC), and compliant with the specifications and eligibility requirements;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


