RESOLUTION No. 2023-07-021

RECOMMENDING THE AWARD OF CONTRACT TO MSN CONSUMER GOODS TRADING FOR THE SUPPLY AND DELIVERY OF VARIOUS ICT SUPPLIES

WHEREAS, included in the CY 2023 Supplemental Annual Procurement Plan No. 5 of the National Prosecution Service, Region 1 is the procurement of ICT Supplies thru Sec 52.1(b)- Shopping of the 2016 Revised Implementing Rules and Regulations of RA No. 9184 and has an Approved Budget for the Contract of Thirty-Two Thousand Three Hundred Thirty-Nine Pesos and 30/100 (Php 32, 339.30);

WHEREAS, the BAC, through its Secretariat, initiated the procurement activity by requesting quotations from seven (7) suppliers, namely: 1) PC4ME One-Stop Computer Corp; 2) Pandayan Bookshop, Inc; 3) Ohana's Consumer Goods Trading; 4) Octagon; 5) MSN Consumer Goods Trading; 6) Paper Cart; and 7) Elyu Supply Enterprises OPC

WHEREAS, in response to the invitation, the BAC obtained five quotations, to wit:

WHEREAS, based on the result, the BAC determined the financial proposal of MSN Consumer Goods Trading in the amount of Thirty-One Thousand Seven Hundred Ninety Pesos (Php 31, 790.00) as the Lowest Calculated Bid;

WHEREAS, upon careful review and evaluation, the BAC found the offer of MSN Consumer Goods Trading responsive to the requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby **RESOLVED** to recommend the award of contract for the subject procurement and the approval of the Purchase Order No. 2023-07-019 in the amount of **Thirty-One Thousand Seven Hundred Ninety Pesos (Php 31, 790.00)** in favor of MSN Consumer Goods Trading for being the Lowest Calculated and Responsive Bidder.


