RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO E12 TECH INC. FOR THE CREATION OF BOARD OF CLAIMS INFOMERCIALS FOR VARIOUS SOCIAL MEDIA PLATFORMS

WHEREAS, as part of its plan to create awareness about the programs of the Board of Claims (BOC), there is a need for the creation of the BOC Infomercials;

WHEREAS, said infomercials will be used on various social media platforms and will be shown in all prosecution offices nationwide;

WHEREAS, the procurement of the said project is included in the approved CY-2023 Annual Procurement Plan (APP) under negotiated procurement with a total allotted budget of Four Hundred Thousand Pesos (₱ 400,00.00);

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project with an approved budget for the contract of Four Hundred Thousand Pesos (₱ 400,000.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department on 19 May 2023;


