RESOLUTION

RECOMMENDING THE APPROVAL OF THE AGENCY-TO-AGENCY AGREEMENT BETWEEN THE DEPARTMENT OF JUSTICE AND THE CIVIL SERVICE COMMISSION-NATIONAL CAPITAL REGION, FOR THE CONDUCT OF IN-HOUSE TRAININGS/SEMINARS

WHEREAS, there is a need to address the organizational/foundational competencies of the employees of the Department of Justice (DOJ);

WHEREAS, in a Memorandum dated 25 April 2023, Training Section Chief Janice G. De Villa stated that aside from being more efficient and economical, entering into an Agency-to-Agency agreement with the Civil Service Commission-National Capital Region (CSC-NCR) will develop the learning and development environment of the DOJ and enrich the core and functional competencies of its personnel;

WHEREAS, the CSC-NCR, being the government's premiere agency for human resources, will provide direct training and personnel development interventions through the following courses:

Program Course/Title
Basic Customer Skills
Values Orientation Workshop

WHEREAS, the Agency-to-Agency agreement with the CSC for the conduct of the said online trainings and seminars are included in the approved CY-2023 Supplemental Annual Procurement Plan No. 2 (SAPP No. 2) with a total allotted budget of Four Hundred Forty-Six Thousand Pesos (₱ 446,000.00);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. 9184 (2016 RIRR), *Agency-to-Agency*¹ is the Procurement from another agency of the government (i.e., Servicing Agency) that has the mandate to deliver goods or services or to undertake infrastructure projects or consultancy services as required by the Procuring Entity;

No. 9184 and its 2016 Revised Implementing Rules and Regulations.
