RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO MR. DENNIS CHRISTOPHER DEE DOING BUSINESS UNDER THE NAME OF DVK PHILIPPINES ENTERPRISES FOR THE SUPPLY AND DELIVERY OF OFFICE SUPPLIES NOT AVAILABLE AT THE PROCUREMENT SERVICE

WHEREAS, on 15 August 2023, The Department of Justice (DOJ), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (ITB) for the Supply and Delivery of Office Supplies Not Available at the Procurement Service;

WHEREAS, the ITB for the aforementioned project was posted in the DOJ and PhilGEPS websites, and in a conspicuous place within the Department with an Approved Budget for the Contract of Nine Million Six Hundred Eighty-Four Thousand Six Hundred Forty-Seven and 63/100 Pesos (₱ 9,684,647.63);

WHEREAS, the procurement of this project is included in the CY 2023 Supplemental Annual Procurement Plan No. 7 (SAPP 7) with an allotted budget of Nine Million Six Hundred Ninety-Five Thousand Eighty-Five and 87/100 Pesos (₱ 9,695,085.87);

WHEREAS, in the pre-bidding conference held on 3 August 2023, the following prospective bidders participated, namely, DVK Philippine Enterprises, EPD School, Office Supplies and General Merchandise, and Stanley Brandley Inc.;

WHEREAS, during the opening of bids held on 23 August 2023, six (6) of the following bidders submitted their bid proposals namely:

WHEREAS, after being determined to be the single lowest calculated bid, the bid submission of DVK Philippines Enterprises, was referred to the Bids and Awards Committee – Technical Working Group (BAC-TWG) for post-qualification and noted the following findings:

WHEREAS, after review and evaluation, the BAC-TWG was able to establish that DVK Philippines Enterprises submitted the single lowest, calculated, and responsive bid and is legally, financially, and technically capable to undertake the said project pursuant to the post qualification report dated 29 August 2023;

NOW THEREFORE, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **MR. DENNIS CHRISTOPHER DEE** doing business under the name of **DVK PHILIPPINES ENTERPRISES** for the **SUPPLY AND DELIVERY OF OFFICE SUPPLIES NOT AVAILABLE AT THE PROCUREMENT SERVICE** in the amount of **EIGHT MILLION THREE HUNDRED EIGHTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (₱ 8,388,800.00)**, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
