**RECOMMENDING THE AWARD OF CONTRACT TO CONCEPT AND INFORMATION GROUP, INC. (DAILY TRIBUNE) FOR THE PUBLICATION OF LIST OF PERSONS DEPRIVED OF LIBERTY IN COMPLIANCE WITH THE GUIDELINES FOR RECOMMENDING EXECUTIVE CLEMENCY**

**WHEREAS**, there is a need for the Department of Justice (DOJ) to publish the list of Persons Deprived of Liberty (PDL) being considered for Executive Clemency in a newspaper of general circulation for one (1) calendar day, in compliance with the Guidelines for Recommending Executive Clemency;

**WHEREAS**, the said publication is included in the approved CY-2023 Supplemental Annual Procurement Plan No. 5 (SAPP 5) under negotiated procurement with an allotted budget of One Hundred Fifty-Six Thousand Pesos (₱ 156,000.00);

**WHEREAS**, pursuant to the rules on *Negotiated Procurement-Procedures for Scientific, Scholarly or Artistic Work, Exclusive Technology, and Media Services*<sup>1</sup>, a market study was conducted wherein Daily Tribune, The Manila Times, and Philippine Daily Inquirer submitted their respective quotations for the said publication;

**WHEREAS**, the result of proposals submitted as shown in the abstract of quotation, are as follows:


