RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO E-COPY CORPORATION FOR THE PURCHASE OF VARIOUS CONSUMABLES AND SPARE PARTS OF SHARP AR-6031N FOR THE OFFICIAL USE OF THE BOARD OF PARDONS AND PAROLE

WHEREAS, Ms. Joan Louise E. Beberino, Administrative Officer V, Board of Pardons and Parole, requested for the purchase of the following various consumables and spare parts for Sharp 6031N copier machine, *to wit*:

WHEREAS, the procurement of consumables for various photocopying machines is included in the CY-2023 Annual Procurement Plan (APP) of the Department with Direct Contracting as the mode of procurement;

WHEREAS, a certificate of distributorship and guarantee to supply dated 28 March 2022 was issued by Sharp Corporation through its Asia Marketing Center General Manager Osamu Narita certifying that e-Copy Corporation (e-Copy) is the sole and exclusive distributor authorized to apply for eligibility and to bid on all "SHARP" multi-function digital copiers, including its accessories, consumables and spare parts in the Philippines;

WHEREAS, e-Copy Corporation submitted a quotation for the said consumable items and spare parts for Sharp 6031N copier machine in the total amount of Twenty-Four Thousand Nine Hundred Eighty-Two Pesos (₱ 24,982.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to alternative mode of procurement of Direct Contracting, and further recommend the award of contract to **E-COPY CORPORATION**, as exclusive distributor of Sharp Corporation, for the purchase of various consumables




