RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO MS. GEMMA T. SOMES, DOING BUSINESS UNDER THE NAME GEMSTONE ENTERPRISE, FOR THE SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURES OF THE DEPARTMENT OF JUSTICE COTTAGE IN BAGUIO CITY

WHEREAS, there is a need for the supply and delivery of various furniture and fixtures for the Department of Justice, (DOJ) Cottage in Baguio City;

WHEREAS, the procurement of this project is included in the CY 2023 Supplemental Annual Procurement Plan (SAPP) No. 4 with an allotted budget of One Million Four Hundred Two Thousand Two Hundred Sixty-Five Pesos (₱ 1,402,265.00);

WHEREAS, the Invitation to Bid (ITB) for the aforementioned project with an Approved Budget for the Contract of One Million Four Hundred Two Thousand Two Hundred Sixty-Five Pesos (₱ 1,402,265.00) was posted in the DOJ and PhilGEPS websites, and in a conspicuous place on 23 June 2023;

WHEREAS, in the pre-bidding conference held on 03 July 2023, four (4) prospective bidders participated; Design Excellence, Infinite DCI, JC Maple Trading and Aira Hacuda;

WHEREAS, during the opening of bids held on 17 July 2023 at 9:30 am, only one (1) bidder submitted its bid:

WHEREAS, after being determined to be the single calculated bid, the bid submission of Gemstone Enterprise was referred to the Bids and Awards Committee - Technical Working Group (BAC-TWG) for evaluation and post-qualification, and noted the following findings:



No. 9184 and its 2016 Revised Implementing Rules and Regulations.
