WHEREAS, CD Technologies Asia, Inc. submitted a quotation for the said subscription to the Lex Libris Bulletins and Network Licenses for CY 2023 in the amount of Two Hundred Forty Thousand Two Hundred Forty Pesos (₱ 240,240.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby
