## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACTS TO PHILIPPINE DAILY INQUIRER, INC. AND THE PHILIPPINE STAR, FOR THE PUBLICATION OF THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 11930 IN TWO (2) NEWSPAPERS OF GENERAL CIRCULATION**

**WHEREAS**, there is a need for the Department of Justice (DOJ) to publish the Implementing Rules and Regulations of Republic Act No. 11930 otherwise known as the "Anti-Online Sexual Abuse and Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act" in two (2) newspapers of general circulation;

**WHEREAS**, the said publication is included in the approved CY-2023 Annual Procurement Plan (APP) under negotiated procurement with an allotted budget of Seven Hundred Fifty Thousand Pesos (₱ 750,000.00);

**WHEREAS**, pursuant to the rules on *Negotiated Procurement-Procedures for Scientific, Scholarly or Artistic Work, Exclusive Technology, and Media Services*<sup>1</sup>, the DOJ Communications Division conducted a market study from three (3) newspapers of general circulation, *to wit*:

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to Negotiated Procurement thru Scientific, Scholarly or Artistic Work, Exclusive Technology, and Media Services and further recommend the award of contracts to **PHILIPPINE DAILY INQUIRER** and **THE PHILIPPINE STAR** for the publication of the Implementing Rules and Regulations of Republic Act No. 11930 in two (2) newspaper of general circulation in the amount of **THREE HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED FORTY FOUR PESOS & 40/100 (₱ 317,444.40)** and **THREE HUNDRED SIXTY-SIX THOUSAND NINE HUNDRED TWELVE PESOS (₱ 366,912.00)**, respectively, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
