RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO LCV CARTECH AUTOMOTIVE & REPAIR SERVICES FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE REPAIR AND MAINTENANCE OF THE SERVICE VEHICLE OF THE REGIONAL PROSECUTION OFFICE – CARAGA REGION THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (SEC. 53.9)

WHEREAS, there is a need for the RPO-Caraga to maintain its government service vehicle in good running condition for the safety of its passengers;

WHEREAS, the BAC Secretariat prepared a purchase request (PR # 2023-06-0009) with an approved budget of Eight Thousand Four Hundred pesos (₱8,400.00);

WHEREAS, the procurement project is included in the approved CY-2023 Supplement Annual Procurement Plan (No. 4) under Negotiated Procurement;

WHEREAS, the BAC Secretariat sent a request for quotation to at least three (3) local suppliers and in response to the procurement opportunity the prospective suppliers submitted their quotations, to wit:


