**“RESOLUTION RECOMMENDING FOR THE APPROVAL OF AWARD OF WINNING BID FOR THE LIVE-IN TRAINING FOR PNP LAW ENFORCERS ON CASE BUILD-UP BY DOJ PROSECUTORS ON SEPTEMBER 25-27, 2023”**

**WHEREAS, there is an approved Purchase Request (PR) dated August 15, 2023, with an Approved Budget for the Contract (ABC) of THREE HUNDRED SEVENTY-FIVE THOUSAND (P375,000.00) pesos only for the procurement of meals, venue rental specifically with breakout rooms and basic lights and sound set-up, and hotel accommodation within Tacloban City for fifty (50) participants;**

**WHEREAS, this activity is included in the Supplemental Annual Procurement Plan (SAPP) Number 5, and such procurement is approved by the BAC in Resolution Number 28 dated August 18, 2023, through Alternative Method under Negotiated Procurement of the Revised IRR of RA 9184;**

**WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:**

- 1. Posted Request for Price Quotation (RFQ) at the Philippine Government Electronic Procurement System (Philgeps) on August 21, 2023; and at the Bulwagan ng Katarungan Bulletin Board, Tacloban City, DOJ official website and official RPO-VIII Procurement Facebook page on August 22, 2023; with set submission on or before August 25, 2023;**
- 2. Requested quotations from three (3) suppliers of known qualifications, to wit:**
  - 2.1 HOTEL ESTRELLA, Real St., Tacloban City;**
  - 2.2 HOTEL COSTA BRAVA, San Jose, Tacloban City;**
  - 2.3 ROBINSONS LAND CORPORATION/ SUMMIT HOTEL TACLOBAN, Brgy. 77, Marasbaras, Tacloban City;**
- 3. Received the three (3) price quotations from the aforesaid suppliers/service providers on August 25, 2023;**

**WHEREAS, the BAC opened the submitted quotations on August 25, 2023, at 10:30 in the morning;**

WHEREAS, on the technical aspect of the bid, the BAC found both Hotel Estrella and Hotel Costa Brava to have not submitted the required documentary requirements; while Robinsons Land Corporation/Summit Hotel submitted the following: (1) Platinum Philgeps Membership, (2) Mayor's Permit No. 2023 04570/04571, (3) Sec. Certificate No. 93269A, (4) Tax Clearance Certificate No. LT-126-01-31-0044-2023-E, (5) Annual Income Return and (6) Omnibus Sworn Statement;

WHEREAS, the BAC declared Hotel Estrella and Hotel Costa Brava ineligible for failure to comply with Section 23 Rule VIII of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A 9184;

WHEREAS, the BAC proceeded with the examination of the financial aspect as regards Robinsons Land Corporation/Summit Hotel and found its bid within the ABC;

WHEREAS, Robinsons Land Corporation/Summit Hotel also qualified based on the rating factors for lease of venue;

WHEREAS, submitted quotations have been consolidated in the Abstract of Canvass;

NOW, THEREFORE, on the basis of the foregoing, it is hereby RECOMMENDED to the Head of Procuring Entity (HOPE) that the procurement of meals, venue rental specifically with breakout rooms and basic lights and sound set-up, and hotel accommodation within Tacloban City for fifty (50) participants for the September 25-27, 2023 session, be awarded to "ROBINSONS LAND CORPORATION/ SUMMIT HOTEL," having satisfied the service specifications of the procuring entity and compliant with the technical and financial requirements of the bid.
