“RESOLUTION RECOMMENDING FOR THE APPROVAL OF AWARD OF WINNING BID FOR THE TRAINING FOR PNP LAW ENFORCERS ON CASE BUILD-UP BY DOJ PROSECUTORS ON AUGUST 23-25 AND AUGUST 29-31, 2023”

WHEREAS, there is an approved Purchase Request (PR) dated July 21, 2023, with an Approved Budget for the Contract (ABC) of SEVEN HUNDRED FIFTY THOUSAND (P750,000.00) pesos only for the procurement of meals, venue rental with lights and sound set-up and hotel accommodation within Tacloban City for fifty (50) participants in each session;

WHEREAS, this activity is included in the Supplemental Annual Procurement Plan (SAPP) Number 5, and such procurement is approved by the BAC in Resolution Number 22 dated July 24, 2023, through Alternative Method of Procurement under Negotiated - Small Value Procurement in accordance with Section 53.9 of the Revised IRR of RA 9184;

WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:

1. Posted Request for Price Quotation (RFQ) on July 25, 2023, at the Philippine Government Electronic Procurement System (Philgeps), Bulwagan ng Katarungan Bulletin Board, Tacloban City, DOJ official website and official RPO-VIII Procurement Facebook page and set submission on or before July 28, 2023;
2. Requested quotations from three (3) suppliers of known qualifications, such as:
 - 2.1 HOTEL LORENZA, Tacloban City, with Red Philgeps Membership, Mayor's Permit No. 2023 03492/03493, SEC Registration No. CS200919065, Annual Income Tax Return and Omnibus Sworn Statement;
 - 2.2 HOTEL XYZ, Tacloban City – no documents submitted;
 - 2.3 JACO AND JUS HOTEL AND RESTAURANT CORPORATION, Brgy. 75, Fatima Village, Tacloban City, with Platinum Philgeps Membership, Mayor's Business Permit No. 2023 01287, Sec. Certificate No. CS201619232, Tax Clearance Certificate No. 14-88-10-13-1030-2021-M, Annual Income Tax Return, DTI Certification No. 2023-BOI-00546;

3. Received the three (3) price quotations from the aforementioned suppliers/service providers on July 28, 2023;

WHEREAS, the BAC opened the submitted quotations on July 28, 2023, at 2:00 in the afternoon and has been consolidated in the Abstract of Canvass;

WHEREAS, both the first (1st) and third (3rd) bidders, Hotel Lorenza and Jaco and Juls Hotel and Restaurant Corporation, respectively, offered a quotation within the ABC and submitted all required documents;

WHEREAS, the second (2nd) bidder, Hotel XYZ, indicated “no send billing transaction” in the RFQ, with a bid exceeding the ABC, and did not submit required documents;

WHEREAS, as between the Hotel Lorenza (1st bidder) and Jaco and Juls Hotel and Restaurant Corporation (3rd bidder), we found the offer/quotation of the Jaco and Juls Hotel and Restaurant Corporation, as the Lowest Calculated Responsive Bid (LCRB).

NOW, THEREFORE, on the basis of the foregoing, it is hereby RECOMMENDED to the Head of Procuring Entity (HOPE) that the procurement of meals, venue rental with lights and sound set-up and hotel accommodation within Tacloban City for fifty (50) participants for the August 23-25 and August 29-31, 2023 sessions, be awarded to “JACO AND JULS HOTEL AND RESTAURANT CORPORATION,” having satisfied the service specifications of the procuring entity and being compliant with the documentary requirements prescribed in Sec. 23 Rule VIII, IRR of RA 9184.


