(BAC Resolution No. 2023- 02)

**RECOMMENDING THE AWARD OF CONTRACT
TO T and E ENTERPRISES FOR THE PURCHASE
OF VARIOUS CONSUMABLES FOR PRINTERS**

WHEREAS, there is a need for the purchase of various consumables for printers for the entire Region IV- A & B;

WHEREAS, the DOJ, NPS - Region IV posted its Invitation to Bid for the aforesaid purchase of Various Consumables for Printers in the PhilGEPS, DOJ Website, and in conspicuous place in the City Prosecutor's Office of San Pablo and Office of the Regional Prosecutor, Region IV Hallways continuously for seven (7) calendar days starting 23 June 2023;

WHEREAS, the purchase of the aforementioned goods is included in the Annual Procurement Plan (APP) for CY 2023 of the Department of Justice, with a total allotted budget of **One Million Eighty Eight Thousand Pesos (Php 1,088,000.00)**;

WHEREAS, in response to the invitation, two (2) actual bidders submitted their respective Bids in a Public Bidding, namely; Proverbs Enterprises, with the Office Address at Km 314 National Highway Brgy. Capipiriwan, Cordon, Isabelala; and T and E Enterprises of L6B Naga Road, Pulanglupa Uno, Las Piñas City, Metro Manila. Both personally submitted their bids in the public bidding at ORP, Regional Office, Region IV, Trece Martires Street, San Pablo City, Laguna.

WHEREAS, during the Opening of Bid documents held on 13 July 2023, 02:00 P.M, the following result yielded, to wit:

WHEREAS, the aforesaid bids were referred to the DOJ, ORP- Bids and Awards Committee – Technical Working Group (BAC-TWG) for evaluation and post-qualification, of the following findings;

No. 9184 and its 2016 Revised Implementing Rules and Regulations.
