RESOLUTION RECOMMENDING THE APPROVAL OF PURCHASE ORDER NO. 07-2023 FOR THE SUPPLY AND DELIVERY OF VARIOUS CONSUMABLES FOR PRINTERS OF NPS- REGION VI.

WHEREAS, there is an urgent need to purchase various consumables (ink for printer) for the official use of the City, Provincial and Regional Prosecution Offices in Region VI;

WHEREAS, the procurement of the aforementioned goods is included in the Supplemental Annual Procurement Plan No. 1 (SAPP No.1) for the CY 2023 of the Department Proper and the Approved Budget for the Contract (ABC) is Two Hundred Sixty Six Thousand Four Hundred Pesos (P 266,400.00);

WHEREAS, Regional Prosecution Office VI through its Bids and Awards Committee (BAC), posted the Request for Quotation (RFQ) for the above mentioned project through posting at the Philippine Government Electronic Procurement System (PHILGEPS), the Iloilo Hall of Justice and the Iloilo Provincial Capitol;

WHEREAS, the posting was made last July 21, 2023-July 24, 2023, 2:00 p.m.;

WHEREAS, the opening of bids was July 24, 2023 4:00 p.m. and four (4) suppliers submitted their quotations. An Abstract of Quotation was prepared as follows:


WHEREAS, due to the exigency of the procured items and accessibility of the supplier to the end-user the BAC instead recommended to engage a local supplier;

WHEREAS, after the opening of bids, Amada Enterprises had the lowest bid price in the amount of P 140,000.00 and followed by Lunarchem Trading amounting to P 193, 000.00, the BAC Secretariat contacted Amada Enterprises and Lunarchem Trading for further evaluation of authenticity and quality of the product but they did not responded.

WHEREAS, per evaluation, the proposal of Iloilo Yca-Dale Trading was found to be compliant with the specifications and details of the duly accomplished RFQ together with the requirements;

NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend the award and approval of the Purchase Order No. 07-2023 in the amount of Two Hundred Sixty Six Thousand Three Hundred Ninety Eight Pesos (Php 266,398.00) for the supply and delivery of genuine various consumable ink for City, Provincial and Regional Prosecution Offices, Region VI in favor of Iloilo Yca-Dale Trading.




