RESOLUTION RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURES FOR NPS REGION V UNDER NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT, SECTION 53.9) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA) NO. 9184.

WHEREAS, the Department approved the budget of Three Hundred Eighty-Two Thousand Three Hundred Seventy-Two Pesos Only (₱ 382,372.00) for the Supply and Delivery of Various Furniture and Fixtures for NPS Region V;

WHEREAS, in compliance with Section 21.2 of the Revised IRR of RA 9184, DOJ NPS Region V thru its BAC Secretariat advertised the Request for Quotation (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS), DOJ Website, and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned;

WHEREAS, the BAC Secretariat sent Request for Quotations (RFQ) for the procurement of the above-mentioned project to the following suppliers on 09 February 2023, to wit: (1) Legazpi General Merchandise; (2) Legazpi Jebson Trading; (3) SL Ruiz Corporation; and (4) Lucky Educational Supply, Inc.;

WHEREAS, the Submission and Opening of Bids was scheduled on 15 February 2023;

WHEREAS, quotations from five (5) suppliers were received by the BAC Secretariat on different dates, attested by the accomplished Request for Price Quotations (RFQ), and the following is the result of the evaluation during the Opening of Bids:

4. Legazpi Jebson Trading		₱ 381,560.00	- ELIGIBLE, bid offer is within the Approved Budget for the Contract, and compliant with the documentary requirements and technical specifications.


WHEREAS, after judicious evaluation of the submitted quotations, bid of SL Ruiz Corporation is found to be compliant with the specifications and eligibility requirements;




