



BAC Resolution No. 2023-059

**RECOMMENDING THE AWARD OF CONTRACT TO
1214 BUDGETWISE VARIETY STORE FOR THE PROCUREMENT
OF ORDINARY OFFICE SUPPLIES FOR THE 4TH QUARTER OF 2023**

WHEREAS, the **DEPARTMENT OF JUSTICE-NATIONAL PROSECUTION SERVICE Region 02 (DOJ-NPS)** has an allotted budget of **One Hundred Ninety-Seven Thousand Nine Hundred Nineteen Pesos and Twenty-Six Centavos (Php 197,919.26)**, for the procurement of ordinary or regular office supplies for the 4th quarter of 2023;

WHEREAS, in accordance with Section 52.1(b)(Shopping), in relation to Section 21.2.1 of the 2016 Revised IRR of R.A. 9184, the Request For Quotation (RFQ) for the procurement of the said supplies was originally published on October 09, 2023;

WHEREAS, on October 16, 2023, BAC **Resolution No. 2023-051** was issued, dispositive portion of which provides:

"NOW, THEREFORE, after thorough deliberation the Committee **RESOLVES**, as it hereby resolves, to **RECOMMEND** the following:

1. To **DECLARE A FAILURE OF BIDDING** for the procurement of supplies and delivery of office supplies for the 4th quarter of 2023; and
2. To **re-bid and re-advertise** the Request For Quotation in accordance with Sections 35.1(c), 35.2, and 35.3, in relation to Sections 21.2.1 and 54.2 of the 2016 Revised IRR of RA 9184;"

WHEREAS, consequently the Committee re-posted the RFQ, adjusting the number of units to be purchased on some items conformably with the above-mentioned sections of the 2016 Revised IRR of R.A. No. 9184, in the PhilGEPS, DOJ website, and in a conspicuous place at the premises of DOJ-NPS Region 02 for twelve (12) days starting October 25, 2023;

WHEREAS, four (4) suppliers responded and submitted their respective bids to the Committee, however, only three (3) were evaluated because the last supplier was late in submitting its bid, thus:

WHEREAS, after due evaluation and assessment, the Committee established the following, to wit:

1. Based on the foregoing Abstract, the bids of **Adilynne's General merchandise** and **4R Enterprises** exceeded the ABC thus both were disqualified from the bidding leaving **1214 Budgetwise Variety Store** as the remaining bidder;
2. The Committee determined that the quotation of **1214 Budgetwise Variety Store** not only to be below the ABC but is also compliant with all the specifications prescribed by the Committee;
3. In view of the following consideration, the Committee unanimously declares the bid of **1214 Budgetwise Variety Store** as the lowest calculated and responsive bid (LCRB) and is most advantageous to the government;

NOW, THEREFORE, after thorough deliberation the Bids and Awards Committee **RESOLVES**, as it hereby resolves, to **RECOMMEND** the awarding of the contract to **1214 Budgetwise Variety Store** for the procurement of ordinary or regular office supplies for the 4th quarter of 2023 amounting to **One Hundred Ninety-Seven Thousand Three Hundred Sixteen Pesos (Php 197,316.00)**;
