RESOLUTION No. 2023-09-038

BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR LEASE OF VENUE WITH MEALS AND ACCOMMODATION FOR THE CONDUCT OF TRAINING OF DOJ PROSECUTORS AND LAW ENFORCEMENT AGENTS OF THE PNP – SESSION 10

WHEREAS, included in the approved CY 2023 Supplemental Annual Procurement Plan No. 5 of the Department of Justice (DOJ) is the Training of DOJ Prosecutors and Law Enforcement Agents of the PNP consisting of several sessions to be conducted by the Regional Prosecution Offices of DOJ;

WHEREAS, there are twenty-two (22) sessions allotted for NPS- Region 1;

WHEREAS, NPS- R1 intends to hold the 10th session of the said training on September 18-20, 2023 in any hotel located in Bauang, La Union;

WHEREAS, the subject procurement has an Approved Budget for the Contract of Three Hundred Seventy-Five Thousand Pesos (Php 375, 000.00) and shall be undertaken through Section 53.10 (Lease of Venue) of the 2016 Revised IRR of RA 9184;

WHEREAS, the BAC issued Resolution No. 2023-08-034, duly approved by the Head of the Procuring Entity (HOPE), stating that there is no available government-owned facilities within the area that complies with the requirements of the end-user, hence, the need to resort to privately-owned facilities;

WHEREAS, on August 29, 2023, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC) Secretariat, initiated the procurement activity by sending the RFQ to four (4) lessors, viz: (1) Marand Resort and Spa; (2) D'Jewel-Jade Resort; (3) Villa Veronica Resort and Resto Bar; and (4) Jorisan Waterfront Resort;

WHEREAS, in response to the invitation, the following have submitted their proposals:

Villa Veronica Resort and Resto Bar	306, 250.00

WHEREAS, D'Jewel-Jade Resort, 1st Lowest Calculated Bidder (LCB), was declared disqualified for exceeding the allowable unit price per person for room accommodation. Moreover, upon inquiry and confirmation with the said bidder, they cannot comply with the room requirements stated in the RFQ since they only have limited rooms;

WHEREAS, the BAC proceeded with the evaluation of the proposal and other documents of the 2nd LCB, Marand Resort and Spa, and conducted the post-qualification and evaluation process on the said bidder in accordance with the technical specifications prepared by the BAC pursuant to Appendix B, Annex H of the 2016 Revised IRR of RA 9184;

WHEREAS, upon careful review and evaluation, Marand Resort and Spa garnered a passing rate of 97.55%. Thus, the BAC found the offer of the said lessor responsive to the

requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;

NOW, THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE to recommend to the Head of the Procuring Entity the award of contract for lease of venue with meals and accommodation for the subject procurement in favor of Marand Resort and Spa and the approval of Purchase Order No. 2023-09-034 with a contract price of Two Hundred Ninety-Seven Thousand Five Hundred Pesos (P297,500.00).
