RESOLUTION No. 2023-05-017

RECOMMENDING THE AWARD OF CONTRACT TO R2MMM PHARMA AND MEDICAL SUPPLIES TRADING FOR THE SUPPLY AND DELIVERY OF VARIOUS COVID19 RELATED ITEMS FOR NPS-REGION 1

WHEREAS, included in the CY 2023 Supplemental Annual Procurement Plan No. 3 of the National Prosecution Service, Region 1 is the procurement of COVID-19 related supplies with an allocated budget of One Hundred Three Thousand, Five Hundred Twelve Pesos and 91/100 (P103, 512.91) to be procured in accordance with Sec. 52.1 (b) -Shopping of the 2016 Revised IRR of RA 9184;

WHEREAS, the Regional Prosecution Office 1, through the Bids and Awards Committee (BAC), posted the subject procurement in the PhilGEPS and in a conspicuous place in the premises of the City of San Fernando, La Union and the Justice Hall, Sevilla, San Fernando City, La Union continuously from May 11-17, 2023;

WHEREAS, on the scheduled issuance of price quotation, the BAC, thru its secretariat, sent the Request for Quotation (RFQ) for the above project to four (4) prospective suppliers, namely: (1) R2MMM Pharma and Medical Supplies Trading; (2) Pandayan Bookshop Inc; (3) Ohana's Consumer Goods Trading; and (4) Elyu Supply Enterprises OPC;

WHEREAS, in response to the invitation, all the above suppliers submitted their quotation within the deadline of bid submission. Hereunder are their respective bids:

WHEREAS, based on the result, the BAC determined the financial proposal of R2MMM Pharma and Medical Supplies Trading in the amount of One Hundred Three Thousand Three Hundred Two Pesos and 50/100 (Php 103, 302.50) as the Lowest Calculated Bid;

WHEREAS, upon careful review and evaluation, the BAC found the offer of R2MMM Pharma and Medical Supplies Trading responsive to the requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;


NOW, THEREFORE, on the basis of the foregoing, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby **RESOLVED** to recommend the award of contract for the subject procurement and the approval of the Purchase Order No. 2023-05-015 in the amount of One Hundred Three Thousand Three Hundred Two Pesos and 50/100 (Php 103,302.50) in favor of R2MMM Pharma and Medical Supplies Trading for being the Lowest Calculated and Responsive Bidder.




