**RESOLUTION**

**A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO PARK INN BY RADISSON BACOLOD FOR LEASE OF VENUE FOR THE TRAINING FOR PNP LAW ENFORCERS ON CASE BUILD-UP BY THE DOJ PROSECUTORS ON SEPTEMBER 11, 12 to 13, 2023.**

**WHEREAS**, there is a need for a venue for the Training for PNP Law Enforcers on Case Build-Up by the DOJ Prosecutors on September 11, 12 to 13, 2023 to be held at Bacolod City Negros Occidental;

**WHEREAS**, the procurement for the lease of venue for the said event is included in the approved FY 2023 Supplemental Annual Procurement Plan No. 5 (SAPP no. 5) with allotted budget of **One Hundred Fifty Three Million Pesos (P 153, 000, 000.00)**;

**WHEREAS**, the Approved Budget for the Contract (ABC) of this event is Three Hundred Ninety Thousand Pesos (P 390,000.00);

**WHEREAS**, the posting was made on August 15-18, 2023 at 2:00 p.m. for the above-mentioned project through for the Request for Quotation in the Philippine Government Electronic Procurement System (PHILGEPS), DOJ website, Iloilo City Government Office, and Iloilo Provincial Capitol;

**WHEREAS**, the opening of bids was on August 18, 2023 at 4:00 p.m., in the course of the evaluation of the bids by the BAC the following are the results:




