RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO MALLBERRY SUITES BUSINESS HOTEL FOR THE PROCUREMENT OF LEASE OF VENUE WITH MEALS AND ACCOMODATION FOR THE CONDUCT OF TRAINING FOR PNP LAW ENFORCERS ON CASE BUILD-UP BY DOJ PROSECUTORS IN CAGAYAN DE ORO CITY ON SEPTEMBER 4-6, 2023

WHEREAS, the RPO 10 BAC prepared the Term of Reference for the procurement of lease of venue for 3 days with meals and accommodation (50 pax ) on September 4-6, 2023 with an Approved Budget for the Contract (ABC) of P 390,000.00;

WHEREAS, on August 3, 2023 the RPO-10 Bids and Awards Committee (BAC) served the Request for Quotation for the said procurement project .The RPO-10 BAC also invited the following Suppliers to submit their respective quotations/ proposals: 1) Mallberry Suites Business Hotel 2) N-Hotel 3) Pearlmont Hotel;

WHEREAS, per evaluation, the proposal of Mallberry Suites Business Hotel found to be compliant with the requirements, and its price quotation amounting to P 348,000.00 is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid.

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of Contract to the Head of the Procuring Entity of his/her duly authorized representative.

NOW THEREFORE, for and in consideration of the foregoing, WE, the members of RPO-10 BAC, hereby recommend to Regional Prosecutor Merlynn Barola-Uy, Head of the Procuring Entity pursuant to Department Order No. 783 dated December 06, 2017 the following:

- (1) AWARD OF CONTRACT via Small Value Procurement to Mallberry Suites Business Hotel for the of lease of venue for 3 days with meals and accommodation (50 pax ) on September 4-6, 2023 in the amount P 348,000.00 inclusive of appropriate taxes and fees.
- (2) GRANT OF AUTHORIZATION for the BAC Chairperson to sign the corresponding Notice of Award and Notice to proceed to implement this resolution.
