

## CONTRACT AGREEMENT FOR SECURITY SERVICES

THIS AGREEMENT made the \_\_\_\_\_ day of \_\_\_\_\_ 20\_\_\_\_ between DEPARTMENT OF JUSTICE-NATIONAL PROSECUTION SERVICE REGION 02 (DOJ-NPS R02) of the Philippines (hereinafter called "the Entity") of the one part and ITAWES SECURITY PROACTIVE AGENCY, INC.(ISPAI) of Pallua Road, Pallua Sur, Tuguegarao City, Cagayan (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **security and related services for January 01, 2023 to December 31, 2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION NINE HUNDRED THIRTY-THREE THOUSAND EIGHT HUNDRED ONE PESOS AND FORTY-FOUR CENTAVOS (Php 1,933,801.44)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws, such as but not limited to the creation of Trust Fund for the deposit of retirement benefits for the security guards as committed by the

Supplier during the conduct of clarificatory meeting on December 28, 2022, and/or the Procuring Entity concerned in the PBDs.

3. In consideration for the sum of **ONE MILLION NINE HUNDRED THIRTY-THREE THOUSAND EIGHT HUNDRED ONE PESOS AND FORTY-FOUR CENTAVOS (Php 1,933,801.44)** or such other sums as may be ascertained, **ITAWES SECURITY PROACTIVE AGENCY, INC.(ISPAI)** agrees to render security and related services for January 01, 2023 to December 31, 2023 in accordance with his/her/its Bid.
4. The **DEPARTMENT OF JUSTICE-NATIONAL PROSECUTION SERVICE REGION 02 (DOJ-NPS R02)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
