## RESOLUTION

### RECOMMENDING THE AWARD OF CONTRACT TO L' FISHER HOTEL FOR THE CONDUCT OF REGIONAL OPERATIONS AND MANAGEMENT WORKSHOP OF THE NATIONAL PROSECUTION SERVICE REGION VI ON JUNE 14-16, 2023

**WHEREAS**, there is a need for a venue for the conduct of the Regional Operations and Management Workshop of the National Prosecution Service Region VI on June 14-16, 2023;

**WHEREAS**, the procurement of lease of venue for the said event is included in the approved Supplemental Annual Procurement Plan (APP) for CY 2023 with an allotted budget of Three Hundred Fifty-Seven Thousand Pesos (Php 357,000.00);

**WHEREAS**, in a Memorandum dated 12 April 2023, Ms. Melissa Joy A. Ohao, Administrative Officer V of the Office of the Regional Prosecutor VI, averred that the activity will be held in a private facility since there is no available government-owned venue that could accommodate the said event;

**WHEREAS**, pursuant to the Procedures for *Lease of Privately-Owned Real Property and Venue*<sup>1</sup> request for quotations were sent to hotels in Bacolod City;

**WHEREAS**, the abstract of canvass prepared by the end-user, and the result of the proposal submitted by these prospective venues showed that the L'Fisher Hotel submitted the lowest calculated and responsive quotation, to wit:




