**BIDS and AWARD COMMITTEE (BAC) RESOLUTION**  
**DECLARING FAILURE OF BIDDING and TO RE-BID FOR THE PROCUREMENT**  
**ONE (1) YEAR SUBSCRIPTION OF 100 MBPS LEASED LINE INTERNET**  
**CONNECTIVITY FOR THE TWENTY-FOUR (24) SUBSTATIONS/OFFICES OF DOJ,**  
**REGION IV**  
(BAC Resolution No. 01, series of 2023)

**WHEREAS**, the Office of the Regional Prosecutor, Region IV, through the Bids and Awards Committee (BAC), posted the Invitation to Bid for the aforesaid project with the Approved Budget Ceiling of **One Million Two Hundred Forty-One Thousand Seven Hundred Eight Pesos only (Php 1,241,708.00)** on **April 28, 2023 to May 5, 2023**. The said Invitation was then posted simultaneously in the PhilGEPS Website, DOJ Website and at the conspicuous place within/near the premises of the Regional Prosecution Office of Region IV in San Pablo City, Laguna.

**WHEREAS**, on May 5, 2023, in response to the said invitation, two (2) prospective bidders attended the virtual Pre-bidding conference namely: Converge Information and Communications Technology Solutions, Inc. and InfiniVAN Inc.;

**WHEREAS**, on May 19, 2023, during the submission and opening of bids, none of the above-stated prospective bidders availed of the Official Bidding Documents and thus, no bids are received by this Office;

**WHEREAS**, under Section 35 (1)(a) of Republic Act (RA. No. 9184) and its Implementing Rules and Regulations states that the BAC shall declare the bidding a failure when no bids are received during the allotted period of time;

**NOW THEREFORE**, WE, the members of the Bids and Awards Committee (BAC), pursuant to Section 35 of R.A 9184 and its Implementing Rules and Regulations, hereby **RESOLVE AS IT IS HEREBY RESOLVED** to declare **FAILURE OF BIDDING** of its Procurement of One (1) Year Subscription of 100 Mbps Leased Line Internet Connectivity for Twenty-Four (24) Substations/Offices of the Department of Justice, Region IV. As such, we hereby recommend to the HOPE the following proposal/s:

1. To DECLARE the FIRST (1<sup>ST</sup>) FAILURE OF BIDDING for PB2023-01 for the Procurement of One (1) Year Subscription of 100 MBPS Leased Line Internet Connectivity for the 24 Sub-stations/offices of Department of Justice, Region IV;
2. To INSTRUCT the END-USER TO CONDUCT A MANDATORY REVIEW AND EVALUATION OF THE TERMS, CONDITIONS, AND SPECIFICATIONS IN THE BIDDING DOCUMENTS, including the determination of its cost estimates and bases on the findings. These end-users are likewise mandated to revise the terms, conditions, and specifications, and if necessary, adjust the ABC (Approved Budget Ceiling) subject to the required approvals, pursuant to Section 35.2 and 35.3 of Republic Act 9184 and its Implementing Rules and Regulations;
3. To CONDUCT a RE-BIDDING with RE-ADVERTISEMENT and/or POSTING, as provided for in Section 21.2 of RA 9184 and its Implementing Rules and Regulations.
