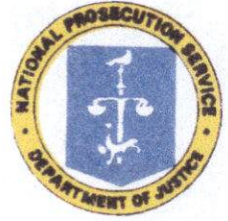

4. Bidders may quote for any or all items.
5. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or your duly authorized representative/s.
6. Late submission of quotation shall not be accepted.
7. Award of Contract shall be made to the Lowest Calculated and Responsive Bidder which complies with the specification and other terms and conditions as stated herein.
8. Award contract shall be made to the lowest Calculated and Responsive Bidder which complies with the specification and other terms and conditions as stated herein.
9. The Lowest Calculated and Responsive Bidder shall be informed immediately.

In case of two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, The ORP-Region VI shall adopt and employ "drawlots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005
