RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO NATURE'S VILLAGE RESORT FOR THE CONDUCT OF MODERN WORKPLACE TRAINING AND CONFLICT MANAGEMENT WORKSHOP OF THE OFFICE OF THE REGIONAL PROSECUTOR VI ON JUNE 16, 2023

WHEREAS, there is a need for a venue for the conduct of the Modern Workplace Training and Conflict Management Workshop of the Office of the Regional Prosecutor VI on 16 June, 2023;

WHEREAS, the said event is included in the approved Annual Procurement Plan (APP) for CY 2023 with an allotted budget of Forty-Five Thousand Pesos (Php 45,000.00),

WHEREAS, as indicated in the approved Annual Procurement Plan, the procurement of meals and room accommodations shall be undertaken through Section 53.10 Lease of Venue in relation to Item (9), (c), (ii) of Annex "H", under Negotiated Procurement method of the 2016 Revised IRR of R.A. 9184;

WHEREAS, in a Memorandum dated 9 May 2023, Ms. Melissa Joy A. Ohao, Administrative Officer V of the Office of the Regional Prosecutor VI, averred that the activity will be held in a private facility since the only available government-owned venue that could accommodate the said event has no PhilGEPS registration;

WHEREAS, pursuant to the Procedures for *Lease of Privately-Owned Real Property and Venue*¹ request for quotations were posted in the PhilGEPS website;

WHEREAS, in response to said request, only Nature's Village Resort has submitted their quotations within the deadline of the bid submission;

WHEREAS, the quotation received was evaluated using the Table Rating Factors for Lease of Venue, wherein Nature's Village Resort attained a rating of 96%;


WHEREAS, after review and evaluation, the BAC-Technical Working Group found that Nature's Village Resort bid to be responsive to the requirements of the end-

NOW THEREFORE, The Bids and Awards Committee **RESOLVES**, as it hereby resolved to recommend the award of contract to the **NATURE'S VILLAGE RESORT**, as the venue for the conduct of the Modern Workplace Training and Conflict Management Workshop of the Office of the Regional Prosecutor VI on June 16, 202, in the amount of **FORTY-FIVE THOUSAND PESOS (Php 45,000.00)**, following the procedures prescribed in R.A. 9184 AND ITS 2016 Revised Implementing Rules and Regulations.


