BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR LEASE OF VENUE WITH MEALS FOR TRAINING FOR PNP LAW ENFORCERS ON CASE BUILD-UP BY DOJ PROSECUTORS ON NOVEMBER 6-8, 2023

WHEREAS, included in the approved Supplemental Annual Procurement Plan (SAPP) Number 6 of NPS IX is the conduct of training for PNP Law Enforcers on Case Build-up by DOJ Prosecutors with an approved budget for the contract of **Three Hundred Seventy Five Thousand (Php. 375,000.00)** allocated for the venue and meals and shall be undertaken through Negotiated Procurement Section 53.10 (Lease of Venue) of the implementing Rules and Regulations of Republic Act No. 9184.

WHEREAS, the subject activity is conducted on-site and will be held in a private hotel due to insufficiency of space in the Department facility subject to compliance with health and safety standards.

WHEREAS, on August 22, 2023, the Regional Prosecution Office Region IX through the Bids and Awards Committee, initiated the procurement activity by sending then Request for Quotation to 3 lessors, viz: **(1) Mardale Hotel; (2) Guillermo Real Estate Corporation; and (3) Kok Tzi Development Inc. (Chandler Suites);**

WHEREAS, in response to the invitation, the BAC received from the same lessors, to wit;

WHEREAS, the BAC had determined that the submitted financial proposal of Garden Orchid Hotel in the amount of **Three Hundred Seventy Five Thousand (Php. 375,000.00)** for Breakfast, AM snacks, Lunch, PM snacks, Dinner, Room Accommodation and Function room as the Lowest Calculated Bid;

WHEREAS, upon the review and evaluation of the compliance with the technical specifications and financial documents submitted, the BAC found the offer of Grand Astoria Hotel as the Lowest Calculated and Responsive Bid;

NOW, THEREFORE; we the Members of the Bids and Awards Committee, hereby **RESOLVE** to recommend to the Head of Procuring Entity the award of contract for lease of venue with meals to Garden Orchid Hotel and the approval of **Purchase order no 2023-12-12** in the amount of **Two Hundred Seventy Six Thousand Seven Hundred Fifty (Php. 276,750.00)**.


