RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PLDT, INC. FOR THE STRUCTURED CABLING INSTALLATION FOR THE NEW JUSTICE CENTER BUILDING OF THE DEPARTMENT OF JUSTICE

WHEREAS, there is an urgent need to procure structured cabling installation for 1 run 100 pairs MDF outdoor cable from PABX room to New Justice Center building, 2 run 25 pairs MDF indoor cable from new building left wing to new building right wing plus communication grounding with "roughing-ins";

WHEREAS, the Department's current telecommunications provider is PLDT, Inc. that covers seamless integration and PABX System;

WHEREAS, the procurement of the aforementioned goods is included in the approved Supplemental Annual Procurement Plan (SAPP) No.6 with an allotted budget of Seven Hundred Eighty-Two Thousand Pesos (P782,000.00);

WHEREAS, in a Memorandum dated 13 November 2019, Engr. Rodolfo C. Florentin, Director II-Administrative Service, averred that maintaining PLDT as the Department's telecommunications provider is more efficient and more economical, and PLDT has the capability of continued system and technical support;

WHEREAS, direct contracting is a mode of procurement that may be resorted to when the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the existing contract;


NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to recommend the **APPROVAL** of the alternative method of procurement through direct contracting, and further recommends the award of contract to PLDT, Inc., in the amount of Seven Hundred Eighty-One Thousand Five Hundred Thirty-Six Pesos (P781,536.00), following the procedures prescribed by R.A. 9184 and its 2016 Revised Implementing Rules and Regulations.
