RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE CREAMERY CATERING TO PROVIDE THE CATERING SERVICES FOR THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING (IACAT) GROUNDBREAKING CEREMONY AS PART OF THE WORLD DAY AGAINST TRAFFICKING (WDAT) TO BE HELD AT DSWD SANCTUARY, ADDITION HILLS, MANDALUYONG CITY ON 31 JULY 2019

WHEREAS, there is a need for a supplier to provide catering services for the conduct of the IACAT's Groundbreaking Ceremony as part of WDAT to be held at DSWD Sanctuary, Addition Hills, Mandaluyong City, on 31 July 2019;

WHEREAS, the procurement of catering service for the said event is included in the approved FY 2019 Annual Procurement Plan (APP) with an allotted budget of One Million One Hundred Forty-Two Thousand Five Hundred Pesos (P1,142,500.00);

WHEREAS, in a Memorandum dated 25 July 2019, IACAT Executive Officer Ms. Aubrey V. Bastareche-Lucero, averred that there are no available government owned caterer to cater the needs of the end-user;

WHEREAS, pursuant to the *Procedures of Small Value Procurement*¹, the Department requested from three (3) catering service providers to submit quotations namely: JIOE the Art of Catering, The Creamery Catering, and M The Passion for the Perfect Taste;

WHEREAS, among the three (3) catering service providers that submitted its quotations, The Creamery Catering provided the lowest calculated quotation/bid, as follows:
