RECOMMENDING THE AWARD OF CONTRACT VIA NEGOTIATED PROCUREMENT [SMALL VALUE PROCUREMENT] AS AN ALTERNATIVE MODE TO NEW ERA AUDIO & LIGHTS SALES & RENTALS IN THE PROCUREMENT OF COLOR ME RUN PACKAGE FOR THE ADVOCACY FUN RUN IN CELEBRATION OF THE INTERNATIONAL DAY AGAINST TRAFFICKING [IDAT]

WHEREAS, the Deputy Executive Director Atty. Ma. Yvette T. Coronel of IACAT Secretariat issued Memorandum dated 15 November 2019 for BAC Chairman requesting for the issuance of BAC Resolution to proceed with the procurement of purchase and for the Advocacy Fun Run in celebration of International Day Against Trafficking [IDAT] in Butuan City;

WHEREAS, the National Prosecution Service - Region XIII [NPS Region XIII] - Bids and Awards Committee prepared the Request for Price Quotation for the procurement of color me run package for the said celebration with a total Approved Budget for the Contract [ABC] of Fifty Thousand Pesos [P50,000.00];

WHEREAS, said procurement project shall be sourced from the DOJ Annual Procurement Plan [APP] for the Calendar Year 2019;

WHEREAS, on November 18, 2019, National Prosecution Service - Region XIII [NPS Region XIII] - Bids and Awards Committee posted /published the Request for Price Quotation for the procurement project; that the said RFQ was posted in the Phil-GEPS website and similar Requests for Price Quotation [RFQ] were personally delivered to three [3] probable providers in Agusan del Norte;

WHEREAS, the deadline for the submission of price quotations was set on November 22, 2019; and, that, only New Era Audio and Light Sales & Rentals, Butuan City submitted a bids;

WHEREAS, it is determined that New Era audio and Light Sales & Rentals is the lone supplier and provider of color me run package in Agusan del Norte, per Certification hereto attached;


WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements, the proposal of **NEW ERA AUDIO & LIGHTS SALES & RENTALS**, conformed to all the specifications and requirements set by DOJ-RPO 13 and the law, and its Price Quotation of **Fifty Thousand Pesos [P50,000.00]**, which is within the ABC, is the most economical and advantageous to the Government, thereby rendering the same as the single calculated and responsive quotation;

WHEREAS, Section 12 of RA No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;


NOW THEREFORE, for and in consideration of the foregoing, WE, the members of National Prosecution Service - Region XIII [NPS Region XIII] - Bids and Awards Committee resolves, as it is hereby **RESOLVED**:




